Membership Meeting Notes - March 9, 2022

Grand Knight Thom Laughery called the meeting to order at 7:02 pm with prayer.

Roll Call of Officers: Missing were the Chaplain and Lecturer, both excused. Ralph Blamer motioned to approve the minutes from last month's meeting, Frank Hare 2nd. Voted upon and passed.

Chaplains Report: Absent, no report.

Membership and Reading of Applications: Tim Lee reported we currently have 259 members, up 5 members this year, with one transfer out. Once Supreme approves the 24 names on the submitted new "Affiliate Member" list, they will be removed from our roster and this will reduce our goal of new members from the current 12 to 9 or 10.

Grand Knight's Report: GK Thom Laughery received a letter from the Ohio State Council pertaining to the support of Seminarians Campaign that is due by 4/15/22; if you received from the Ohio State Council 4 tickets at \$10 each for "The Road to the FINAL FOUR" sweepstakes program, return money and completed ticket stub to Gary Eckstein by 3/17/22; passed around a letter from Dustin Goodchild in regards to an update on the St. Paul Outreach program that Dustin is involved with at St. Thomas University, we had sponsored the program last year: received Thank You cards from Barb Serrano, Youth Minister at Seton, pertaining to greatly appreciating our support for the young people in the SPY program, and also one from the Seton parish St. Vincent de Paul Society for our \$500 donation; thank you for all the members that worked the first Fish Fry, served 765 meals, normal is 650; sent an email in regards to the ZOOM Joe Jordan presentation on "Purpose Driven Retirement Strategies" on 3/10/22 at 7:30 pm. Introduced and welcomed guest Kelly Sabelhaus who recently moved to Pickerington from IN, Kelly is a 3rd degree Knight, has 3 daughters, and since 2010 was Chairman of the United Way Caring program for his community in IN.

Chancellor Report: Dick Petersen referred to his Chancellor's Corner article in the 3/1/22 newsletter, Lent is a time to think about our prayer life, how much time do we delegate to our prayer life, try to increase it during Lent and try to create a relationship with God.

Treasurer Report: DJ Murphy sent out the financial report to the officers and program chairs, let him know if there are any questions or if anyone wants the numbers, all bills have been paid, entries have been properly reconciled. Reported that the MOM Group that our Council's donation for providing desserts at 3 of our Fish Fries is their primary source of income which is turned over to the Parish which has an escrow account for them, they use the money for flowers for Seton Gardens, gift cards for mothers in need, and a birthday party for kids. Our Council received a \$700 credit card gift from Richard & JoAnn Houze to use \$200 for the Coat Drive and \$500 as a general donation.

Financial Secretary Report: Frank Hare reported that all reports are up to date. The "Affiliate Member" list of 24 members has been submitted to Supreme.

Advocate: Mark Decker stated that he has completed the first draft of revising our Council's By-Laws which were last revised in 2004 and sent them to the Grand Knight, Deputy Grand Knight, Financial Secretary and Trustees for their review.

Deputy Grand Knight: DGK Francis Wilamosky will send a Thank You card to Richard & JoAnn Houze for their \$XXX donation; let him know if you have anything to put in the bulletin: looking for someone to volunteer to take over the Public Relations role starting 7/1/22 as he takes on the Grand Knight position, need weekly articles submitted to the Parish Secretary for the bulletin. Thanked the Knights that were Greeters at this past weekend masses.

Trustee Report: Jesus Garcia, no report.

Report of the Fourth Degree: Wayne Patterson stated the next Assembly meeting is Wednesday, 3/16/22 at 6:30 pm in the PAC,

everyone welcomed, with a Corn Beef & Cabbage meal, winner of the February Chili Cookoff gift card was Frank Hare. He will be a delegate at the District Meeting on 3/26/22 at St. Leonard's in Heath voting for a new Master. He mentioned the off-site formal social event for 4th degree members on Sunday, 3/20/22, going to 9:30 am Mass at Seton, then having breakfast in Herrmann Hall and attending the matinee play, "Arsenic and Old Lace", at Pickerington Community Theater with the Assembly paying for it, 12 couples plan to attend.

Report on Programs and Committees

Program Director: Bob Coholich is in the process of updating the web site for the various programs, will be sending an email to the Directors if he needs more information.

Benevolent: Absent, no report.

Community Director: Absent, no report.

Church Director: Wayne Patterson reported that the SOS, Support Our Seminarians, donation for the Seminarians at the Josephinum which is used for Seminarian's emergency use is due 4/15/22. At the 3/4/22 Fish Fry \$XXX was collected for SOS, currently has \$XXX and would like to donate at least \$XXX.

Family Director: Chuck Slaby reported that the St. Patrick's Dance is 3/19/22, will need volunteers to help decorate the PAC either Friday evening after the Fish Fry on 3/18/22 or Saturday morning, 3/19/22; promoting Good Friday services via posters; Easter Egg Hunt is the Saturday 4/16/22; and still taking nominations for "Family of the Year" until the end of March, let either him or Thom Laughery know.

Right To Life: Absent, no report.

Cinnamon Roll Sale: Mark Decker stated that the Cinnamon Roll Committee is planning to have the next one on 4/24/22.

Fish Fry: Frank Hare reported that the Fish Fry Committee of 6 greatly appreciated those that worked the 3/4/22 Fish Fry, sign up for future ones, picked up 800 lbs. of fish on 3/7/22, need additional desserts from the Knights for weeks 2, 4, 6 as the MOMS Group does weeks 1, 3, 5, could use volunteers at noon to scope tartar sauce, coleslaw, applesauce, etc., thanked Jay Oconer and the Boy Scouts for selling pop. The Video Coordinator for the Diocese will be at the 3/11/21 Fish Fry as we are 1 of the top 12 fish fries in the Diocese.

Unfinished Business:

MOTION: Wayne Patterson made a motion to donate up to \$XXX to the Parish to purchase new vestments, stoles, and Eucharistic supplies, 2nd by Dan Murphy, decided to table as more information is needed at this time as Wayne is working with Father Leo to get an itemized list.

MOTION: Frank Hare made a motion to publish in the newsletter to spend up to \$2,000 from the Capital Benefits Fund to purchase a new ice machine for the PAC, split the cost 50/50 with the Parish, plus pay all the plumbing cost to move the ice machine, 2nd by Jesus Garcia. Discussion occurred as the actual Council cost was \$XXX to replace the ice machine in the PAC kitchen, voted upon and passed.

MOTION: Chuck Slaby made a motion to spend up to \$XXX from the Family Budget for the St. Patrick's Dance on 3/19/22 and the Easter Egg Hunt on 4/16/22, 2nd by Mark Decker. Discussion occurred, voted upon and passed.

MOTION: Dan Murphy, instead of donating to the "American Wheelchair Mission" since they do not provide any wheelchairs to the State of Ohio, made a motion to donate \$XXX from the Community Budget to the Fairfield Center for disabilities and CEREBRAL PALSY to purchase medical equipment for their "Equipment Loan Closet" program where wheelchairs, walkers, canes, crutches, etc., are distributed free of charge to anyone in need who then return the item when they are no longer in use, 2nd by Tim Lee. Discussion occurred, voted upon and passed.

GK Thom Laughery and Dan Murphy then presented them with a check from our Council.

Grand Knight Thom Laughery called the meeting to order at 6:50 pm with prayer including the quote from Pope Francis listed in The Little Black Book for 3/29/22 dedicated to Fr. Michael McGivney, on this day in 2008, Pope Benedict XVI declared Fr. McGivney “venerable”.

Council Officer Duties

Gentlemen, the time has come for our election of officer's for the next fraternal year. Many ask at this time, of the duties of the positions. These are listed here below for your consideration.

Not included here, Financial Secretary and Lecturer, are appointed by either the Grand Knight or Supreme.

For any of you who wish to eventually attain the position of Grand Knight, a good practice (but, not a requirement) is to hold all offices.

This aids you in directing your officers once in the top spot.

Grand Knight: The Grand Knight is responsible for the welfare of the council. He presides over council meetings, acts as an ex-officio member of all committees, appoints a membership and programming director, convenes officers for a monthly meeting, and ensures all necessary reports are submitted to the state and Supreme Council. He should also be aware of the council's financial status and ensure that his signature appears on all checks drawn. The Grand Knight is a member of the Advisory Board with general supervision of the council's Columbian Squire circle.

Deputy Grand Knight: The Deputy Grand Knight is second in command. He assists the Grand Knight with council affairs and fulfills all duties assigned to him by the Grand Knight. Should the Grand Knight be absent from a council meeting, the Deputy Grand Knight presides. He is chairman of the council's retention committee and also a member of the Advisory Board charged with overseeing the council's sponsored Columbian Squires circle.

Chancellor: The Chancellor has a variety of responsibilities. Primarily, he assists the Grand Knight and the Deputy Grand Knight in the execution of their duties and oversees the council in both their absences. He is charged with strengthening the members' interests in council activities. The Chancellor is chairman of the admission committee and a member of the Columbian Squires circle ceremonial team.

Recorder: The Recorder is similar to a court reporter or a secretary. He is responsible for maintaining a true record of all actions of the council and its correspondence.

Treasurer: The Treasurer is responsible for the safekeeping and maintaining records of all council funds and accounts. He is responsible for depositing money into the council's accounts and provides a certificate of such monies to the Grand Knight. He is also responsible for payment of all expenses.

Advocate: The Advocate is the legal representative of the council and serves as the council's attorney at trials and investigations of any interest to the council. While he does not need to be a member of the legal profession, he should be familiar with the council by-laws, the Order's Charter, Constitution and Laws, Methods of Conducting a Council Meeting, and Robert's Rules of Order.

Warden: The Warden is the 'watchdog' for council property and degree paraphernalia, except the property of the financial secretary, treasurer and recorder. He is also responsible for setting up the council chambers for meetings and ceremonial work. During ceremonial exemplifications, he will appoint and supervise guards.

Inside/Outside Guards: The Guards have similar responsibilities, but distinct differences. The Outside Guard tends to the outer door admitting visitors and members to the inner door. Once at the inner door, the Inside Guard checks to make sure that their membership cards are current.

Board of Trustees: The Board of Trustees consists of three members elected by the council and the Grand Knight, who serves as chairman of the board. They oversee the work of the Financial Secretary and Treasurer, and with the Deputy Grand Knight serve on the council's retention committee. During council elections, only the Three-year Trustee is voted on, with the others moving on to become two and one-year trustees, respectively.
