

#### Lecturer's Reflection

Sarcasm

There is something I am guilty of and that is sarcasm. Generally speaking, we tend to think of sarcasm as good-natured joking. Sarcasm is heavily present in movies and television shows, and society seems to think that having a sarcastic sense of humor is a good thing. However, if we really think about what sarcasm is, there isn't anything good-natured about it. The word *sarcasm* itself derives from the Greek word *sarkazein*, meaning "to speak bitterly, sneer," or more literally, "to strip off the flesh (like dogs)"; there is nothing good natured about sarcasm.

St. Paul, in his Letter to the Ephesians (4:29) states, "Let no evil talk come out of your mouths, but only such as is good for edifying...that it may impart grace to those who hear." And in his Letter to the Colossians (4:5-6), "Conduct yourselves wisely toward outsiders...let your speech always be gracious, seasoned with salt."

I think there is something important to St. Paul's words. Our attitude, our speech, needs to keep in mind two groups of people: those within the Church and those outside the Church. For those within the Church, sarcasm is detrimental because sarcasm does not build up the Mystical Body of Christ - it tears the Body down. There is nothing grace-filled about sarcasm. Our speech should be used to edify and build up the Mystical Body of Christ - which is all of us.

For those outside the Church, sarcasm is detrimental because it will encourage them to think that following Christ is a sham. They will think, "There's no love, no holiness in that church. Quite frankly, if that's the example of a believer in Christ, then I want no part of that. I don't need Jesus to be a good person because it's obvious that those who believe in Christ are no better." St. Paul in Romans (2:24), referencing Isaiah, writes, "The name of God is blasphemed among the Gentiles because of you."

If we're sarcastic toward others, those people might shrug it off or even laugh about it in our presence, but those words will reside in their memory. Fr. Ondrey remarked that sin begets sin. Because our sarcastic words are not edifying or encouraging, they will easily enable us to continue with additional sarcastic remarks, and that never leads to a positive outcome - once sarcasm starts, it's easy to get carried away and continually make sarcastic responses - I know because I speak from experience.

I suffer from this malady and I'm sure some of you do too. It is a cross to bear but ultimately our Lord wants us to be holy like Him with the help of His grace. Despite the people outside of the Church who may profess to hate our beliefs and us or want nothing to do with our faith, they are still made in the image and likeness of - let's treat them and each other with the same love our Lord has for us. There is no love in sarcasm

#### Council Officer Duties

Gentlemen, the time has come for our election of officer's for the next fraternal year. Many ask at this time, of the duties of the positions. These are listed here below for your consideration.

Not included here, Financial Secretary and Lecturer, are appointed by either the Grand Knight or Supreme.

For any of you who wish to eventually attain the position of Grand Knight, a good practice (but, not a requirement) is to hold all offices.

This aids you in directing your officers once in the top spot.

Grand Knight: The Grand Knight is responsible for the welfare of the council. He presides over council meetings, acts as an ex-officio member of all committees, appoints a membership and programming director, convenes officers for a monthly meeting, and ensures all necessary reports are submitted to the state and Supreme Council. He should also be aware of the council's financial status and ensure that his signature appears on all checks drawn. The Grand Knight is a member of the Advisory Board with general supervision of the council's Columbian Squire circle.

Deputy Grand Knight: The Deputy Grand Knight is second in command. He assists the Grand Knight with council affairs and fulfills all duties assigned to him by the Grand Knight. Should the Grand Knight be absent from a council meeting, the Deputy Grand Knight presides. He is chairman of the council's retention committee and also a member of the Advisory Board charged with overseeing the council's sponsored Columbian Squires circle.

Chancellor: The Chancellor has a variety of responsibilities. Primarily, he assists the Grand Knight and the Deputy Grand Knight in the execution of their duties and oversees the council in both their absences. He is charged with strengthening the members' interests in council activities. The Chancellor is chairman of the admission committee and a member of the Columbian Squires circle ceremonial team.

**Recorder:** The Recorder is similar to a court reporter or a secretary. He is responsible for maintaining a true record of all actions of the council and its correspondence.

**Treasurer:** The Treasurer is responsible for the safekeeping and maintaining records of all council funds and accounts. He is responsible for depositing money into the council's accounts and provides a certificate of such monies to the Grand Knight. He is also responsible for payment of all expenses.

**Advocate**: The Advocate is the legal representative of the council and serves as the council's attorney at trials and investigations of any interest to the council. While he does not need to be a member of the legal profession, he should be familiar with the council by-laws, the Order's Charter, Constitution and Laws, Methods of Conducting a Council Meeting, and Robert's Rules of Order.

Warden: The Warden is the 'watchdog' for council property and degree paraphernalia, except the property of the financial secretary, treasurer and recorder. He is also responsible for setting up the council chambers for meetings and ceremonial work. During ceremonial exemplifications, he will appoint and supervise guards.

**Inside/Outside Guards**: The Guards have similar responsibilities, but distinct differences. The Outside Guard tends to the outer door admitting visitors and members to the inner door. Once at the inner door, the Inside Guard checks to make sure that their membership cards are current.

**Board of Trustees**: The Board of Trustees consists of three members elected by the council and the Grand Knight, who serves as chairman of the board. They oversee the work of the Financial Secretary and Treasurer, and with the Deputy Grand Knight serve on the council's retention committee. During council elections, only the Three-year Trustee is voted on, with the others moving on to become two and one-year trustees, respectively.

If you have any questions, please contact any of the current officers.

Yes it is that time of year again. The Trustees will be accepting nominations for the 2023/24 Council year. If you are a 3rd degree Knight and interested in leading the council during the year, now is the time to take action.

**Proposed Ohio Constitutional Amendments** 

58% of Ohioans believe in abortions. Some of those are Catholics.

The people behind the amendments need to gather 413,000 valid signatures from 40 counties by August.

If passed:

Abortion would be legal through all 9 months of pregnancy with zero restrictions.

Parental Consent would be removed. This also includes gender reassignment surgery.

Health and safety standards for abortion mills would be revoked.

Taxpayers would be required to pay for abortions.

Steps that our pro-life lawmakers are taking to counteract some of this:

Right now, passage of a constitutional amendment requires only 50% + 1 of votes. A resolution has been introduced raising the passage rate to 60% of the votes.

The SAFE Act has been introduced that would outlaw gender reassignment surgery for people under 18 years of age.

Please in support of this bill are going to be nasty bullies. We need to learn how to counteract that with kindness. It is believed that the radicalness of these constitutional amendments will be off putting to some and they will vote against it. We don't want to lose those votes in by being like the supporters of the amendments.
