Chancellor's Corner - WORDS MATTER

Which would you rather hear, words that are critical and mocking of you, or a compliment on something you did.

Martin Luther's explanation of the eighth commandment tells us that we should not just "bear false witness" against neighbors, but also suggests that we "speak well of them". Words do matter, as well as the way words are perceived from one person to the other. Sometimes, a person we have had a bad experience with can say anything positive that they can to us, but we perceive those words in a different way than what was meant.

Words that are positive and pleasant are considered "wise of heart", whereas words that are deceitful and spread strife are like a "scorching fire". In Proverbs 16: 27-30, "A scoundrel plots evil, and on their lips it is like a scorching fire... A perverse person stirs up conflict, and a gossip separates close friends. A violent person entices their neighbor and leads them down a path that is not good. Whoever winks their eye is plotting perversity, whoever purses their lips is bent on evil."

In contrast, Proverbs 16: 9-21, "The lips of a king speak as an oracle, and his mouth does not betray justice. In their hearts, humans plan their course but the Lord establishes their steps. ... Kings take pleasure in honest lips; they value the one who speaks what is right. ... How much better to get wisdom than gold, to get insight rather than silver. The highway of the upright avoids evil, those who guard their ways preserve their lives.... The wise in heart are called discerning, and gracious words promote instruction."

In Matthew 15: 10, Jesus said "Listen and understand. What goes into someone's mouth does not defile them, but what comes out of their mouth, that is what defiles them." So, we should watch what we say, and then think before we say anything.

What is Veterans Day?

November 11, 2018 is Veterans Day. "Veterans Day is an American holiday honoring military veterans. Both a federal holiday and a state holiday in all states, it is always celebrated on November 11th each year. It is also celebrated as Armistice Day or Remembrance Day in other parts of the world, falling on November 11, the anniversary of the signing of the Armistice that ended World War I. (Major hostilities of World War I were formally ended at the 11th hour of the 11th day of the 11th month of 1918 with the German signing of the Armistice.)"

In 1954 the Holiday was changed from Armistice Day to Veterans Day to honor American Veterans of all wars. The difference between Veterans Day and Memorial Day? Memorial Day honors service members who died in service to their country or as a result of injuries incurred during battle. Deceased veterans are also remembered on Veterans Day, but the day is set aside to thank and honor living veterans who served honorably in the military - in wartime or peacetime.

Respect Life Committee

The **Ohio Right to Make Reproductive Decisions Including Abortion Initiative** may appear on the ballot in Ohio as an initiated constitutional amendment on November 7, 2023.

The ballot initiative would provide that each individual has the right to make and carry out one's own reproductive decisions, including but not limited to decisions regarding contraception, fertility treatment, continuing one's own pregnancy, miscarriage care, and abortion. The measure would provide that the state of Ohio cannot penalize, discriminate, or interfere with an individual's exercising of this right, and that the state of Ohio may regulate abortion after fetal viability unless if it is necessary to protect the life or health of the pregnant patient.¹

Lecturer's Reflection

As Knights, during our exemplification, we are told: *Tempus Fugit, Memento Mori*, and this translates to: "Time Flies, Remember Your Death." The remembrance of our death is preparation for our bodily resurrection. Now, in the Gospel of Matthew (17:14-21), we read about a man bringing his epileptic son to Jesus for healing, because the man took his son to Jesus' disciples and the disciples could not heal the son. After Jesus rebukes the demon, the boy is "cured instantly." Shortly after the curing, the disciples ask Jesus why they could not cure the boy. Jesus' responds, "Because of your little faith...if you have faith as a grain of mustard seed, you will say to this mountain, 'Move from here to there,' and it will move." So how does *Memento Mori* and the faith to move mountains tie in together?

First, let's go back earlier in Matthew's Gospel. In Chapter 10, Jesus calls his twelve disciples and "gives them authority over unclean spirits, to cast them out, and to heal every disease and infirmity," and then they are sent out to do exactly that and apparently are very successful. How is it that early on, the disciples are able to cast out demons and heal the sick but now they can't cast out the demon we just heard about?

In our own lives, anytime we come into contact with something new and exciting, we take to it like fish to water. A lot of times, this new thing becomes constant in our thoughts and brings us such joy. However, over time, the brand new and exciting thing becomes ordinary and we still like it but it does not stay at the forefront of our thoughts. Now, this is strictly my opinion but I think something similar happened to the disciples. When Jesus first calls them, they are curious but in awe. There is something that draws them in but they can't explain it; they just go with it and eventually become part of the "inner circle", so to say.

Now they've seen Jesus do many great things: calming storms, healing people, multiplying the loaves and fish, casting out demons, etc. In the case of the epileptic boy, the disciples can't cast out the demon because, although they believe, I think they figure that because they are Jesus' disciples, the demon should be cast out with no problem. But this is not case - the disciples are not able to cast out the demon.

In our own lives, do we think because we are Catholic and attend Mass weekly, that we are in the "inner circle"? According to a 2019 Pew Research Center report, only one-third of U.S. Catholics believe in transubstantiation¹, i.e., that the communion host and wine truly turns into the Body and Blood of Jesus after consecration. That means two-thirds of our brothers and sisters do not have faith that the host and wine truly turn into the Body and Blood of Jesus. My brothers, let us remember that the disciples were with Jesus physically every day, they were physically with God in the flesh! Yet they could not cast out a type of demon that they probably cast out before because of their little faith.

Earlier I mentioned *Memento Mori*, to *remember your death*. Ultimately, this means that we reflect on our death daily...not once a week, or once a month, but daily, as we do not know the time and place when our physical death will happen - death does not discriminate by age. Integral in this daily remembrance of death is faith. Do you have faith and truly believe in your bodily resurrection? I hope so. Because without faith, *Memento Mori* means nothing. So have great faith my brothers.
